3.) The ACPS Members' Column

As a member of the chemical profession have you ever been annoyed (dismayed, troubled, amused, ...) by the random use of the word "chemical" (read: "toxic, dangerous, evil, ...") in the public media? I certainly have (been annoyed, dismayed, troubled and even amused from time to time), and after 50 or so years in the chemical profession I thought it was still not too late for me to do something about it. I have now just finished giving a course entitled "Chemistry for Informed Consumers" to a class of about 40 organized by the Saskatoon Seniors Continued Learning organization. The course consisted of eight roughly 2-hour sessions on the following topics: the basics (one session on each of chemistry and measurements), chemistry at the supermarket, chemistry in the kitchen, chemistry in the laundry (and other cleaning and waste disposal topics), environmental chemistry (2 sessions) and chemistry "mistakes" (lack of knowledge, studied ignorance and pseudoscience). The result has been most gratifying and I can now say, with some certainty, that when the participants use the term "chemical" they will now include a suitably chosen preceding adjective. Trace chemical constituents in consumer goods (and, of course, all sorts of things) remain a public concern, but will no longer be regarded with uninformed horror by at least 40 Saskatchewan seniors.
